#### Theme 1: Gender norms and stereotypes

Gender norms and stereotypes as barriers to gender equality

Fixed ideas about what women and men should do in the home or at work are learned by girls and boys in early childhood and throughout their lives. These ideas or gender stereotypes affect their choices in school and as they enter careers and contribute to a lack of progress toward equality between women and men. This limits not only the jobs that women and men consider or are available to them, but also can exclude women and men from social roles and tasks.

Please outline what you see as the key barriers/ obstacles and challenges to gender equality under this theme in law, policy and practice.

It needs to be acknowledged that societal norms will take decades to change, but that overtly stereotypical portrayals should be avoided. There is also a tendency in schools to select boys to represent the school, where a girl could fulfil the role just as easily.

Please identify the steps to be taken to address the issues raised and who should address them (e.g. the state, private sector, education system etc.)

All school textbooks need to be examined as they are rife with examples of women shopping for the home, and of men being business leaders and making business decisions. There should be at least one example of a successful woman in each field where an example is shared of a successful man. Schools should track their decision making re roles offered to girls and boys as school representative.

# Theme 2: Work: Occupational segregation by gender, gender discrimination and the gender pay gap

Women and men are often concentrated into different kinds of jobs and within the same occupations, women are often in work that is less well paid and has less opportunities for career advancement. Women often work in areas where they can work part-time so as to fit in with their caring responsibilities. While many men work in low paid jobs, many professions dominated by women are also low paid, and professions that have become female-dominated have become lower paid. This worsens the gender pay gap (the average difference between the wages of women and men who are working).

A lack of appreciation within society regarding the complexity and workload involved in eg teaching, nursing or caring for children, vulnerable adults or elderly. As this work was often seen as rewarding and vocational, how well it was paid was seen as less important.

Please identify the steps to be taken to address the issues raised and who should address them (e.g. the state, private sector, education system etc.)

This would require all stake-holders to work together. Quotas and targets will be required, including some element of enforcement, because a perception that this should change will not always exist. This is an extremely complex endeavour with the variety of types of work involved.

#### Theme 3. Care, paid and unpaid, as a social and family responsibility

<u>Care -- the social responsibility of care and women and men's co responsibility for care, especially within the family</u>

Women remain disproportionately responsible for unpaid care and often work in poorly paid care work. For working parents or lone parents, balancing paid work with parenting and or caring for older and dependent adults presents significant challenges. Women are most disadvantaged by these challenges, yet men also suffer from lack of opportunities to share parenting and caring roles. Despite recent legislation and policy initiatives to support early years parental care, inequalities in the distribution of unpaid care continue between women and men. The cost of childcare has been identified as a particular barrier to work for women alongside responsibilities of caring for older relatives and dependent adults.

## Theme 4: Women's access to, and representation in, public life and decision making

Ensure women's participation and representation in decision-making and leadership in the workplace, political and public life

Women are systematically underrepresented in leadership in economic and political decision-making. Despite the introduction of a candidate gender quota (through the system of party funding) for national political office, and initiatives to support women's access to corporate decision-making roles, men continue to dominate leadership positions. There are also issues to be considered around how media represents women and men.
