


Several Perspectives in Tension

- Road safety and DUID
- Criminal supply and misuse of illicit drugs and prescribable medicines
- Safe and healthy driving
- Healthcare (including psychiatric and mental health) considerations
- Traumatic and violent deaths and self-killing
- Social and recreational uses and decriminlisation or legalization of cannabis

Road Death Statistics 1959-2022



Road Deaths and Serious Injuries to date 2023

- ☐ Ireland's Road Safety Strategy 2021-2023 aims to reduce road fatalities and make roads safer
- □ Vision Zero by 2050
- □ 2013-2017 Road Safety Authority/NDRDI study:
 - ➤ Alcohol a contributory factor in 33% of driver fatalities
 - ➤ Drugs a contributory factor in 29% of driver fatalities
- □ 2021 records showed the lowest number of road fatalities since recording began in 1959
- □ In 2022, road fatalities increased to 155
- □ In 2023 to date, 23% increase on 2022 and surpassing the total for all of 2021
- □ 900 life-shattering injuries to date

Most Recent Changes in Legislation

- □ Road Traffic Act 2016:
 - Preliminary drug testing (oral fluid) including
 Mandatory Intoxicant Testing checkpoints
 - per se drug levels
 - Medical exemption for Δ^9 Tetrahydrocannabinol (but still an offence if impairment evidence)

Statutory Levels (per se)

Drug/Metabolite	Level in Whole Blood
Δ9 -Tetrahydrocannabinol (Cannabis)	1ng/ml
11-nor-9-carboxy-Δ 9 -tetrahydrocannabinol (Cannabis)	5ng/ml
Cocaine	10ng/ml
Benzoylecgonine (Cocaine)	50ng/ml
6-Acetylmorphine (Heroin)	5ng/ml



Medical Cannabis Use

- Misuse of Drugs (Prescription and Control of Supply of Cannabis for Medical Use)
 Regulations 2019 (June)
- □ Limited to -
 - spasticity associated with multiple sclerosis
 - intractable nausea and vomiting associated with chemotherapy
 - severe, refractory (treatment-resistant)
 epilepsy






Drug Driving Prevalence 2013-2022



New Device 2023

- The Securetec DrugWipe® 6S launched on the 1st of December 2022
- Not unlike the now familiar with Covid-19 antigen testing
- Can detect these classes of drugs:
 - Cannabis (THC) 10ng/ml
 - Cocaine 10ng/ml
 - Benzodiazepines (Diazepam) 5ng/ml
 - Opiates (Morphine) 10ng/ml
 - D-Amphetamine 50ng/ml
 - D-Methamphetamine 25ng/ml








DrugWipe Data Review

Submitted Results % Positive




Prescribable and Over the Counter Drugs Summary


- Prescribable and OTC drugs are also a real problem and mirror taking of drugs and medications in Ireland
- Need for vigilance
- Should we be asking the more accurate question about harmful impacts of <u>illicit and improper use</u> of drugs rather than harmful impacts of illicit drugs?
- Examples of licit, prescribable drugs used illicitly or off-prescription: benzodiazepines, Z-drugs, pregabalin, medicinal cannabis, morphine, oxycodone, fentanyl, codeine (OTC)

Prescribable and Over the Counter Drugs Summary

- Patients should their medications as prescribed, be safe on them, read the patient information leaflet and listen to their doctor's and pharmacist's advice
- Message to patients: Drive safely, be aware of own impairment and don't kill or maim others or self or risk losing licence to drive

Forensic Death Inquiries

- □ Coroners Acts 1962-2019
- Inquisitorial process
- No blame or liability or exoneration in verdict
- □ Recommendations may be made to prevent further fatalities

Forensic Death Inquiries

- □ Violent and traumatic deaths include:
 - Homicide
 - Self-killing
 - Accidents
 - Drowning
 - Road Traffic Collisions
 - Accidents at Work

Drug Related Deaths 2020

- □ Direct cause fatal poisoning
- □ Indirect cause contributing factor or present
- Health Research Board Reports
 - National Drug-Related Drugs Index
 - Coronial data

Drug Related Deaths 2020

- In 2020 409 poisoning deaths: opioids,
 benzodiazepines, cocaine, prescribable drugs
- □ Polydrugs in 80% and in combination with alcohol
- □ 397 non-poisoning deaths
 - hanging
 - road traffic crashes
 - falls
 - drownings
- Note: cannabis and death causation
