Detailed Conversation Starters: Facilitators and Note Takers

General Instructions for Roundtable Discussions following presentations:

- 4. Following the presentations, what do you understand to be the international law impacts- if any- on the law relating to abortion in Ireland?
- 5. Given what you have heard, do you think that legislative change on the issue of abortion in cases of fatal foetal abnormalities is possible in Ireland?
