Detailed Conversation Starters: Facilitators and Note Takers

General Instructions for Roundtable Discussions following presentations:

- ➤ Hear from everyone and as you do, enforce the ground-rules, firmly and with good humour. In particular, encourage people to be respectful of others and to share the airtime.
- Remember that the speakers are available for any questions or clarifications if required during the discussion. The Secretariat is also available for any clarification.

- As members may still be nervous/ uncomfortable with speaking in the public Q&A session on this topic later, you should also capture the top 3 questions which emerge in the discussion, and should be prepared to ask them on behalf of the table if called upon to do so by the Judge.
